Did you know?

- According to our Air Force Instruction (AFI) 34-276, Family Child Care: **YOU MUST BE LICENSED TO PROVIDE HOME CARE ...**
1. Any individuals caring for other families' children a total of more than 10 hours a week on a regular basis must be licensed to provide care in on-base quarters.
 2. The family child care coordinator, accompanied by the flight chief, services commander, or security forces, will make an unannounced visit to individuals who are suspected of providing care on a regular basis who are not licensed.
 3. The mission support group commander may revoke the housing privileges of individuals who provide child care but refuse to become licensed.

Note: Any individual caring for other families' children totaling more than 10 hours a week on a regular basis must be licensed to provide care in on-base quarters.
